To afford the student a thorough grasp of the following periods of art: Late Gothic, Renaissance, Mannerism, Baroque, Rococo, Romanticism, Realism-Impressionism, Post-Impressionism, Art Nouveau, Symbolism, Fauvism, Expressionism, Cubism, Futurism, Orphism, Neo-Plasticism, DeStijl, Suprematism, Bauhaus, Dadaism and Surrealism, Abstract Expressionism, Pop Art, New Realism, Minimalism, Earthworks, Conceptual Art, and Process Art.

METHODS

Presentation of this course will be primarily through slide lectures and discussion.

- Students will be able to demonstrate a facility for critical thinking
- Students will be able to describe, analze, interpret and evaluate artworks from the Renaissance to the present.
- Students will be able to articulate formal, technical, historical and conceptual attributes of artworks from the Renaissance to the presence.
- Students will be able to identify and apply visual arts materials, tools, techniques and processes to historical artworks.

The student learning outcomes will be achieved through the use of textboook, lectures, research papers, and gallery reports.
