# **COURSE DESCRIPTION**

Private, applied instruction in a performing area is a vital part of the development of Music majors, as well as an appropriate elective for many non-majors. Each level of study has defined materials and technical masteries to be achieved (see Music Student Handbook for the Department of Music). Students are assigned to a level according to their proficiency and mastery of materials listed for a given level.

# **COURSE LEARNING OUTCOMES**

- Acquire and reinforce principles of healthy vocal technique and develop an awareness and knowledge of how your unique vocal instrument functions and responds.
- Apply vocal technique principles to the interpretation of vocal music in commercial styles.
- Develop and polish performance skills that include memorization, diction, interpretation and communication of text, and deportment.
- Develop skills in time management, organization, self-motivation, listening, goal setting, and research through the daily practice of singing.
- o Gain tools to cultivate habits that enhance a lifestyle as a vocal artist and that can be integrated into other academic, professional, and personal

### **COURSE SCHEDULE**

**Private Lessons** are held once per week for 25-min (1 unit) or 50-min (2 units). A lesson schedule will be assembled by the instructor at the beginning of each semester based on students' availability and maintained for the duration of the term.

**Group Vocal Forums** are held once per week on Wednesdays from 4:00-5:30pm in Crill Hall or the Parlor Room. See Canvas for schedule and for link to Google Drive to sign up for performance dates.

# **COURSE POLICIES**

 PRIVATE LESSONS. Regular, on-time attendance is required. Tardiness will affect your grade. Missing 20% or more of your lessons may result in de-enrollment. Students will be allowed <u>one</u> (1) excused absence during the semester for Weekly Lessons to be used for emergencies or illness.

3. PRACTICING. Regular individual, private practice is expected and is crucial for all students' vocal progress. Students are required to keep track of and submit a weekly log of their practice time via Canvas on Mondays; this counts toward your final grade. Your practice time is expected to include warm-ups and technique exercises, singing assigned music, mapping out assigned music, listening, researching basic information,

to include warm-ups and technique exercises, singing assigned music, mapping out assigned music, listening, researching basic information, story/plot, and history of assigned music, memorizing, and any other assignments given during your weekly lesson. Note: Voice lesson time, worship rehearsals, choir practice, and other extracurricular activities that involve singing do not count toward your practice time.

1 Unit (1/2 hr. lesson): 4-6 hours per week. 2 Units (1 hr. lesson): 8-12 hours per week.

In general, you'll want to devote 70-75% of your practice time to singing and the other 25-30% to other non-singing activities (described above in *Practicing* section).

Also, all students taking lessons have access to 15 mins. per week of rehearsal with pianist, Melva Morrison (first come, first served). I highly encourage you to take advantage of this opportunity (PLUS it counts toward your practice time!) Sign-ups for time with Melva usually go up Wednesday afternoons in the bulletin board by the elevator on the first floor in the Cooper Music Building.

The PLNU Music Department student handbook states, "a student should practice one hour daily for each half-hour lesson per week (1 unit of registration). A student with a one-hour lesson per week (2 units of registration) should practice two hours daily. Students preparing for a junior or senior recital will need more practice time. Specific guidelines are provided in the syllabus for each instructor."

Practice rooms are located in the basement of Cooper Music Center; please see front desk to access them.

Vocal Forum, students must text/call (619) 985-4297 or email at least 4 hours before the lesson time. If you are sick with a fever or any contagious illness, please DO cancel your lesson. If you are aware of an upcoming scheduling conflict for your lessons, I highly encourage you to switch lesson times with another student in our studio (schedule and contact info for classmates located on Canvas).

Make-up lessons: Every effort will be made to accommodate the student's request to reschedule in the case of excused absences or student illness. Lessons that occur on school holidays and unexcused lessons will not be made up. Any lessons that I cancel will be rescheduled at a mutually

### **ASSIGNMENTS**

All assignments are to be submitted through Canvas. Points will be deducted for late assignments.

1. WEEKLY PRACTICE LOGS. Student keeps track of, and will be graded on tracking: (1) weekly goals, (2) all warm-ups, technical exercises, and music selections practiced, (3) listening and music/score study activity, (4) the time spent in each of these activities per day, and (5) total weekly time dedicated to all material. (See Canvas in Assignments section for practice log assignment format). While I am not assigning specific requirements for the exact number of hours students should practice this semester, please follow the Guidelines for Practicing on pg. 2 of this syllabus. It is expected that all material assigned in a lesson will be prepared for the following week's lesson. Thorough tracking and evidence of purposeful and thoughtful individual practice that incorporates concepts covered in lessons will be looked for.

Why? While students can initially grasp concepts presented in private lessons, long-lasting learning happens in practicing these concepts on a regular basis outside of the lesson. It is in the practice room that we get to know how own voice works, reacts, and what it is capable of. Keeping a log is helpful in making sure our practice time is effective and efficient.

- © <u>Due Date</u>: Every Monday. First practice log is due the Monday after the first lesson in the semester and last log is due Monday, December 16<sup>th</sup>.
- 2. VOCAL FORUM PERFORMANCES (3) AND ASSESSMENTS. All students are required to perform three (3) times in the semester during Vocal Forum. Students may perform additional times, but only 3 have to be submitted for this assignment. Students are to record a video each performance (smartphone video is acceptable), watch it, fill out and submit a Vocal Forum Self-Assessment Form. \*Students are allowed use of music during performances that are prior to Fall Break (October 25). After Fall Break, all music must be memorized.


Why? Performing is a vital part of getting to know our unique vocal instrument. Oftentimes, we have different reactions performing in public that are not our "normal" in the practice room or in your weekly lesson. This exercise is an opportunity to develop, evaluate, and improve our presentation skills, and when working with an instrumentalist, our collaborative skills. These skills will not only be valuable for singing, but will also help in other life experiences like interviews, public speaking, lecture teaching, etc.

- ① Due Date: A week after student performs in Vocal Forum.
- 3. CONCERT ATTENDANCE. All students are required to attend two (2) vocal recitals, performances, or concerts. These are to be performances were there is solo singing (choral performances are discouraged for this assignment). Students must attend at least one (1) PLNU Vocal Recital; the other performance can be at PLNU or an outside vocal concert/recital/performance. Picture of program or ticket stub must be submitted on Canvas in addition to completing a "Performance Observations" form (look at Assignments section in Canvas for more details and for Suggested PLNU Vocal Recital event dates.)

Why? In addition to supporting fellow singers, this assignment will help develop critical listening and observation skills. Becoming aware of, identifying and evaluating basic skills of the singing artform in the others' performances will improve our own singing and performing.

<u>Voice Jury or Mock Jury Final Performance</u>. Successful completion of this class requires doing a final voice jury on its scheduled day. The final examination schedule is posted on pg. 1. No requests for early examinations or alternative days will be approved. All music majors with a voice emphasis and vocal scholarship recipients will be required to perform a jury as their final exam at the end of the semester during finals week. All other students will perform a "mock jury" on the final scheduled Vocal Forum class as their final exam. Students tha have done a junior or senior recital are <u>not</u> required to do a voice jury at the end of the semester.

All repertoire performed on a jury must be newly presented by the student without having been presented on a previous jury and must be memorized. Students may select their first piece and faculty will select all other pieces.

\* For Music Majors with a voice emphasis and vocal scholarship recipients: The opening jury piece chosen by the student may not be a piece performed that semester on a departmental recital.

# Repertoire. "What will I be singing?"

Please keep in mind that these events will greatly enhance your knowledge and experience as a singer.

**Cell Phone Use.** Phones may be used to record private lessons and vocal forum performances. Please silence phones during lessons, vocal forums, and any other recital/performances.

**Music Majors with an emphasis in Voice.** Please be aware that music majors have additional performance requirements. While I will assist in reminding and preparing you to meet these requirements, it is your responsibility to fulfill them.

- o The National Association of Teachers of Singing, a professional organization for the field of voice teaching and learning, hold state and regional auditions every year. Please discuss your participation in this competition at your lessons with Prof. Peralta.

• Department Recitals. The Music Department Student Handbook states, "Music majors are required to perform in Departmental Student Recitals (Mondays 4:00 p.m.) at least twice each year during required study in their applied area." The voice faculty will assign department recital performance dates at the beginning of the semester. More experienced/upper-class students will be assigned earlier dates. Date swapping among students will be allowed, in which case the students will be responsible for notifying the instructors and Mary Boles (MaryBoles@pointloma.edu). Non-music majors are highly encouraged, though not required, to participate in a departmental recital once a semester. Please see Handbook for additional requirements.

PLNU Attendance and Participation Policy. Regular and punctual attendance at all classes is considered essential to optimum academic achievement.
