GOALS AND OUTCOMES:

COURSE DESCRIPTION:

This course will study the design and mechanics of research so that useful data can be understood to expand the body of nutrition science. Current scientific literature will be reviewed and applicable research methodologies discussed. The role of statistics in scientific research will also be presented and practiced.

DIETETIC PROGRAM LEARNING OUTCOMES:

Demonstrate content knowledge of food and nutrition as well as concepts and theories of nutrition across a broad range including: lifecycle stages, cellular nutrition, disease prevention and medical therapy; food and food systems; development, modification, and evaluation of recipes, menus and food products.
- 2. Identify and assess scientific research evaluating current evidence-based research related to dietetics.
- 3. Evaluate the effects of societal, cultural, ethical and financial dynamics upon diet trends, dietary choices, and food preparation methods among families and societies.

As a result of participation in this course, students will:

- 1. Describe basic types of research studies that can be used to study nutrition science.
- 2. Interpret, evaluate and synthesize current nutrition research literature to formulate appropriate conclusions;
- 3. Describe and explain how basic types of data analysis are used in inferential statistics;
- 4. Be able to conduct oral presentations on journal articles pertaining to nutrition;
- 5. Write an introduction to a valid nutrition research study.

EXPLANATION OF REQUIREMENTS:

Assignments:

Problem sets available in Canvas; see class schedule for exercises and due dates.

Quizzes:

On assigned chapters; available on Canvas. If you are unhappy with your first attempt, you may have a second attempt, but only the second attempt will save as your grade.

Journal Article, Evaluated and Written:

You will be given a handout on how to evaluate a journal article, and an assigned article. Answer the questions on the handout, to evaluate the article. In the second assignment, you will be given a journal article and you will write the abstract to summarize it.

Research Paper Introduction:

Choose a nutrition research topic and write an introduction, then a literature review outlining past studies. An example is as follows: Does soluble fiber lower blood cholesterol levels? The <u>introduction</u> could include paragraphs describing what soluble fiber is, where it is found, and its benefits. The introduction could also include an explanation of blood cholesterol levels, its components, and normal lab values. The <u>literature review</u> will then summarize studies that report positive or negative outcomes looking at soluble fiber intake on blood cholesterol levels. Try not to get off track and report unrelated aspects of fiber, or other lifestyle and diet aspects that can affect blood cholesterol levels.

For this class, you will only be writing the introduction and literature review, not a full research paper.

Oral Report Presentation:

During finals week, you will orally present one of the articles you used to write your research paper. Using some type of visual form (slide, handout, poster, etc.), summarize and display the significant information, covering the literature review, methods, results and discussion sections. Remember to include the title and where the article was published.
