Early Childhood Learning Center (ECLC) Field Experience Survey Results December 2013

Surveys were given to 83 students enrolled in FCS 150 Human Development (FCS 150 Section One – 42 students/FCS 150 Section Two – 41 students) December, 2013. A total of 79 surveys were returned. Numbers below indicate the total responses for each descriptor. Compiled comments are listed below as well.

Comments:

- 1. It was just too short of time and too few to really make a difference.
- 2. As the semester progressed, I was able to recognize physical, cognitive, and social emotional skills while in the classroom.
