# Early Childhood Learning Center (ECLC) Field Experience Survey Results May 2014

Surveys were given to 107 students enrolled in FCS 120 Child and Adolescent Development (36 students) and FCS 150 Human Development (FCS 150 Section One – 27 students/FCS 150 Section Two – 44 students) May, 2014. A total of 100 surveys were returned. Numbers below indicate the total responses for each descriptor. Compiled comments are listed below as well.
