COURSE DESCRIPTION

Development of personal fitness through assessment, theory, and practice; introduces principles of conditioning, nutrition, and stress management leading to a lifetime of fitness and desirable health practices.

STUDENT LEARNING OUTCOMES

- 1. Students will learn the basic principles, techniques, and mechanics of weightlifting;
- 2. Students will discuss different lifts associated with certain muscle groups
- 3. Students will show proper technique for each lift
- 4. Students will discuss effective workout plans for desired fitness goals.
- 5. Assess current personal lifestyle and develop a plan for optimal lifelong wellness.
- 6. Identify and explain how the health related components of physical fitness contribute to general health and wellness and apply to various exercise activities.
- 7. Identify potential risks as well as the benefits associated with exercise.
- 8. Demonstrate practical techniques for assessing one's own fitness status.

REQUIRED TEXTS AND RECOMMENDED RESOURCES

There is no textbook required for this class. Handouts will be given when needed. Journals and fitness magazines will be useful in finding articles for critiques.

ATTENDANCE AND PARTICIPATION

To be successful as a student in this class, you'll need to arrive on time and attend regularly. Learning to be dependable now will also help you in your life beyond PLNU. If you're absent more than 10% of the time, I may submit a report that could result in your being withdrawn from the class.
