 We attained our criteria for success for all categories and students improved in all categories compared to last year.

#### Changes to be Made Based on Data:

 Changes to course offerings have increased the possibility that some students could complete this paper prior to their senior year. The assessment committee will recommend to the Department Chair that an alternate assignment from the Senior capstone course be considered to meet this criteria.

Rubric Used: We used the AAC&U Information Literacy rubric to assess our students in Information Literacy.

Note. Critical Thinking, Written Communication, and Quantitative Reasoning will be assessed utilizing the GE ETS exam. The Psychology Department will receive the scores from Institutional Research in early June.
