Catalog Course Description:

A review and extension of elementary algebra, solutions of linear and quadratic equations, radicals, inequalities, linear and quadratic functions, polynomial functions, exponential and logarithmic functions, conic sections, sequences and series and graphing. Offered every semester.

Prerequisite(s): MTH 099 (or equivalent).

Learning Outcomes for this Course:

- 1. Students will be able to solve complicated polynomial equations.
- 2. Students will be able to use graphing to solve equations.
- 3. Students will be able to solve problems using polynomial, rational, exponential and logarithmic functions.

Course Philosophy:

Mathematics requires active participation. Participation means: asking questions, making conjectures and checking them, providing solutions to problems, sharing ideas with classmates.

Homework (30%): Homework will be assigned every class meeting. A homework assignment is late if it is not received at the start of class on the due date. No late homework will be accepted; however the two lowest homework scores will be dropped. Please be sure that your homework is stapled together and the

problems are in order. Homework will be scored on a combination of completeness and correctness. A random selection (the same for all people) of the problems will be graded on any homework assignment.

Tests (20% each) and Final Exam (30%): Tests and the Final Exam will include problems and questions over material assigned in the text, readings and handouts, as well as material presented in class.

No examination shall be missed without <u>prior consent by me</u> or a well documented emergency beyond your control. A score of zero will be assigned for an examination that is missed without prior consent or a well documented emergency beyond your control. The examination schedule is included in the daily schedule. I do not intend to accept excuses such as poor communication with parents, benefactors, sport team sponsors and/or travel agents.

If more than twenty (20) percent of the total number of class meetings is reported as missed, the faculty member or VPAA may initiate the student's de-enrollment from the course without further advanced notice to the student. If the date of de-enrollment is past the last date to withdraw from a class, the student will be assigned a grade of W or WF consistent with university policy in the Grading section of the catalog.
