#### **Course Description**

Introduction to the use of a computer algebra system to complement the knowledge of calculus.

#### **Prerequisites**

MTH 144 or a score of 3 or higher on AP 114 or AP 115.

#### **Course Learning Outcomes**

- Students will be able to demonstrate facility with analytical concepts.
- Students will be able to use technology to solve problems.
- Students will be able to speak about their work with precision, clarity and organization.
- Students will be able to write about their work with precision, clarity and organization.
- Students will collaborate effectively in teams.
- Students will be able to identify, locate, evaluate, and effectively and responsibly use and cite information for the task at hand.
- Students will be able to gather relevant information, examine information and form a conclusion based on that information.
- Students will be able to understand and create arguments supported by quantitative evidence, and they can clearly communicate those arguments in a variety of formats.

#### **Examinations**

There will be one midterm exams and a final exam on: **Tuesday April 28, 2020 (last day of class).** Make-up exams will be given only by arrangement prior to the exam scheduled date with the instructor for reasons of documented emergency.

#### Labs

Labs will be assigned on Tuesdays and must be submitted by 11:59 pm the following Tuesday. There will be two lab exams (a midterm and a final).

#### **Grading Policies**

The grade for the labs is based on the weekly labs (40%), one midterm exam (30%) and a final exam (30%).

A passing grade requires getting at least 60% in one of the partial exams or on the final exam. Grades are based on the number of points accumulated throughout the course. Approximate minimal percentages required to obtain a given grade are:

**Late work**. A written assignment or computer assignment is late if it is not received at the beginning of class on the due date. Late work will not be accepted. Make-up tests will be given only by arrangement with the instructor for reasons of documented emergency.

# **Attendance Policy**

Attendance is expected at each class session. In the event of an absence you are responsible for the material covered in class and the assignments given that day. Here is the university's stated policy on attendance:

If you miss 10% of the class, you will receive a warning. If you miss 20% of the class, you will be automatically de-enrolled.

### **Class Enrollment:**

It is the student's responsibility to maintain his/her class schedule. Should the need arise to drop this course (personal emergencies, poor performance, etc.), the student has the responsibility to follow through (provided the drop date meets the stated calendar deadline established by the university), not the instructor. Simply ceasing to attend this course or failing to follow through to arrange for a change of registration (drop/add) may easily result in a grade of F on the official transcript.

#### **Academic Accommodations:**
