Course Description

A continuation of Calculus I supported by the use of computer graphics and a symbolic computer algebra system. Methods of integration, sequences, series, elementary differential equations, polar coordinates and parametric equations.

Prerequisites MTH164 or MTH144, or equivalent.

Examinations

There will be three midterm exams and a final exam on **Monday May 4, 2020 7:30-10:00 am.** Make-up exams will be given only by arrangement prior to the exam scheduled date with the instructor for reasons of documented emergency.

Homework

Homework will be assigned weekly and is due Wednesday the week following class discussion.

Labs

Labs will be assigned on Tuesdays and must be submitted by 11:59 pm the following Tuesday. There will be two lab exams (a midterm and a final).

Attendance Policy

If you miss 10% of the class, you will receive a warning. If you miss 20% of the class, you will be automatically de-enrolled.

Class Enrollment:
