## **Course Description**

A first course in probability and statistics for students with sophisticated mathematics exposure. Topics include axioms of probability, random variables, discrete and continuous distributions, mathematical expectation, limit theorems. Introduction into descriptive and inferential statistics, including the topics of sampling distributions, point estimation and hypothesis testing. Topics are supported through the use of statistical software.

Prerequisites: MTH2074

## **Course Learning Outcomes**

- Students will be able to apply their mathematical knowledge to solve problems.
- Students will be able to use technology to solve problems.
- Students will collaborate effectively in teams.
- Students will be able to understand and create arguments supported by quantitative evidence, and they can clearly communicate those arguments in a variety of formats.

#### **Examinations**

There will be two midterm exams and a final exam on **Friday May 8, 2020 1:30-4:00 pm.** Make-up exams will be given only by arrangement prior to the exam scheduled date with the instructor for reasons of documented emergency. #### Homework

Homework will be assigned weekly and is due Wednesday the week following class discussion.

Labs will be assigned on a regular basis. You may work on labs with others, but your final submission should be your own. It is possible that your code may look similar to those you work with, but it should be clear that the final product is your own.

## **Attendance Policy**

Attendance is expected at each class session. In the event of an absence you are responsible for the material covered in class and the assignments given that day. Here is the university's stated policy on attendance:

Regular and punctual attendance at all classes is considered essential to optimum academic achievement. If you miss 10% of the class, you will receive a warning. If you miss 20% of the class, you will be automatically de-enrolled.

#### **Class Enrollment:**

It is the student's responsibility to maintain his/her class schedule. Should the need arise to drop this course (personal emergencies, poor performance, etc.), the student has the responsibility to follow through (provided the drop date meets the stated calendar deadline established by the university), not the instructor. Simply ceasing to attend this course or failing to follow through to arrange for a change of registration (drop/add) may easily result in a grade of F on the official transcript.

#### **Academic Accommodations:**
