3. Faculty Chair Report (Rebecca Laird, School of Theology & Christian Ministry)

Dr. Laird shared her Faculty Council report with the Committee. In relation to Administration Evaluation, Dr. Laird shared that faculty "feels assessed every minute of every day", so glad to know that Administration are now being evaluated as well. Dr. Laird shared the growing concern of faculty regarding "complex workload" and stated the "simplistic evaluation" of faculty workload is not accurate.

4. Recommendation for Professor Emerita (Kerry Fulcher) Motion by Craig Furusho and second by Don Schengel to recommend that the Board of Trustees accept the recommendation of the President for Faculty Emeritus Status of Dr. Mary Conklin.

## 5. Review of Faculty Handbook-DRAFT

Dr. Fulcher added there are still "2 pieces" that need to be handled – FERPA student protection (what is currently in Handbook is not up to date or accurate to the law). Handbook exceeds what the law requires. Also, missing sections in regards to intellectual property, (i.e., patents, student work, trademark). We currently have general statement in regards to compensation in the Handbook. Dr. Fulcher has looked at other institution policies which is "all over the map".
