Course Description

A problem-based course that explores mathematical modeling techniques using a variety of computational methods. Also examines how mathematics can be applied to answer specific questions. Includes problems from biology, chemistry, physics, business and other non-mathematical disciplines. Written report and oral presentation are required.

- Students will be able to apply their mathematical knowledge to solve problems.
- Students will be able to use technology to solve problems.
- Students will be able to speak about their work with precision, clarity and organization.
- Students will be able to write about their work with precision, clarity and organization.
- Students will collaborate effectively in teams.
- Students will be able to identify, locate, evaluate, and effectively and responsibly use and cite information for the task at hand.
- Students will be able to gather relevant information, examine information and form a conclusion based on that information.
- Students will be able to understand and create arguments supported by quantitative evidence, and they can clearly communicate those arguments in a variety of formats.

Grading Policies

Grades will be computed based on your scores on the following assignments:

- Literature Reviews (9%) There are several literature reviews where you will be asked to read a research paper on a model and give a 5-10 min. presentation on the paper.
- Projects (29%) There will be several projects based on the models we are working on.
- Homework and activities (20%) Regular activities will be collected.
- Comprehensive Exam (14%) In class exam near end of semester.
- Final Project (24%) Presentation of work during final exam time.
- Class Participation (4%) Attending and participation in regularly scheduled zoom meetings
