COURSE DESCRIPTION

This course offers an introduction to a variety of foundational acrylic painting techniques and processes, including direct and indirect painting methods, color mixing strategies, and methods for developing compositional effectiveness.

Through an introduction to the history of painting and contemporary practices in painting, the course is also meant to promote the development of conceptual ideation, personal voice, and historical contextualization as the student develops their own unique, personal painting practice.

LEARNING OUTCOMES

Students will be able to...

- Understand and utilize safe and effective studio methods for painting in acrylic.
- Paint directly and indirectly, using a variety of painting techniques to this end.
- 3. Intentionally mix colors to achieve a range of effects.

- 4. Create a dynamic compositional structure in painting.
- Develop personally relevant conceptual content for their work and communicate such content through painting.
- Show an awareness of a range of precedents for painting, and apply this awareness to their painting practice, in order to begin contextualizing their work within painting's history.
- 7. Exemplify effective work habits including consistency in practice, risk taking, and personal introspection, as well as document the development of their painting process through a journal.

METHODS

Instruction will be given through: live class lectures, demonstrations, small group discussions, one-on-one discussions with the instructor, videos on professional artists, hands on projects, readings, class critiques, peer reviews, and a studio visit with a professional artist.

ASSIGNMENTS + REQUIREMENT

Students are expected to have all basic painting supplies ready to use during each class session. A list of required painting supplies is included on page 7 of this syllabus,

Work outside of class:

This course requires an estimated total of *7 hours of work time each week*. It is essential that you schedule any necessary extra work time outside of class for yourself each week, and consistently come to class showing reflective progress in your work.

Preparation for studio work: It is important that you come to class with painting surfaces gessoed (if applicable) and all supplies and materials ready to use.

Studio safety during the COVID19 pandemic: During work time in the Keller studio, all university COVID19 guidelines must be strictly adhered to.

This includes, but is not limited to:

- Wearing a mask at all times, whether inside or outside.
- Keeping a 6-foot distance from others at all times.
- Staying home if you have any symptoms of COVID19 or have come in contact with someone who has tested positive for COVID19.

It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 112.5 total hours (7 hours per week) meeting the course learning outcomes. The time estimations are provided in the Canvas modules.

Required materials to buy on your own:

- Something to carry your supplies in such as: a tackle box, sturdy canvas bag, etc.
- Paper towels or old rags
- Dish soap
- 2-3 small containers for water (12-30 oz) such as old plastic cups or glass jars
