## **COURSE DESCRIPTION**

An advanced study of works, primarily in translation. The course focuses on selected themes, topics, and/or eras and places the works in their cultural contexts.

Literary periods (dates, writers, characteristics, and important developments) e. Contemporary critical approaches f. Extra-literary research (FELO 1d, 2b)
- 3. Analyze the social, cultural, ethnic, gendered, and/or historical contexts of the works and their authors, and connect the texts with their own lives. (FELO 1d, 2b)

#### COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 2 unit class delivered over 8weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation. In some courses, a portion of the credit hour content will be delivered **asynchronously** and attendance will be determined by submitting the assignments by the posted due dates. # **Asynchronous Attendance/Participation Definition**
