# **COURSE DESCRIPTION**

"Within the context of the history of Israel, an overview of the literature of the Old Testament with special attention to its literary history and theological themes."

This course is one of the components of the Foundational Explorations Program at PLNU, under the category of "Responding to the Sacred." PLNU provides a foundational course of study in the liberal arts informed by the life, death, and resurrection of Jesus Christ. In keeping with the Wesleyan tradition, the curriculum equips students with a broad range of knowledge and skills within and across disciplines to enrich major study, lifelong learning, and vocational service as Christ-like participants in the world's diverse societies and cultures. By including this course in

a common educational experience for undergraduates, the faculty supports the "study of Scripture and Christian heritage as foundational in the pursuit of knowledge and the development of personal values."

#### COURSE LEARNING OUTCOMES

Students will be able to:

- 1. Identify the historical contexts of the Old Testament.
- 2. Articulate the unity of the Old Testament and New Testament in its canonical context within the diverse literature of the Christian canon.
- 3. Articulate and appreciate the ways in which the Bible, understood as given by divine inspiration, functions as the church's central norm for Christian discipleship, faith and practice.
- 4. Articulate the basic content of the books of the Old Testament and the methods appropriate to the interpretation of those books.

## FOUNDATIONAL EXPLORATIONS LEARNING OUTCOMES

FELO 3. Students will demonstrate an understanding of Christian Scripture, Tradition, and Ethics, including engagement in acts of devotion and works of mercy.

## **COURSE CREDIT HOUR INFORMATION**

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 2 unit class delivered over 16 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 75 total hours meeting the course learning outcomes, approximately 2 hours per week in class and 3 hours per week outside of class.

# ASSESSMENT AND GRADING

## **Course Requirements:**

- 1. **Old Testament Readings**. There are ten Old Testament reading assignments worth twenty points each. You will report your reading percentage for each Old Testament Reading assignment and you will write one paragraph on either something that surprised you, something you identified with, or something you learned from the reading. You may only report what you have read this semester. This is worth **10%** of your grade.
- 2. The **Old Testament story and your story**. At the close of the semester you will write a three-page paper reflecting on an episode of Israel's story that connects with your story. This is worth **7%** of your grade and is due on **Tuesday**, **April 26**. You may "build out" a passage that you have already reflected on or go with an entirely different passage.
- 3. A **six-page paper**, worth **18%** of your grade, in which you interpret an Old Testament passage. You may select from a list of suggested passages or you may choose a different passage but it must be approved by the prof. Further instructions for this paper will be given. **The paper is due on Tuesday, April 12.** There is a 10 point penalty for late papers.
- 4. There will be three Module Learning Exams (two midterms and the final). These will be open textbook, open Bible, and open note exams that cover the textbook readings and the lectures for each module. The purpose of each exam is not merely to measure what you have learned, but to increase your learning. Each exam is worth 20% of your grade.
- 5. Lecture Take-aways. Each week students will submit a paragraph on their main "take-away" from the lectures of the week. These combine for 5% of the total grade.
- 6. Attend Class!!! Attendance will be taken and school policies enforced. Regular and punctual attendance at all classes is considered essential to optimum academic achievement. If the student is absent from more than 10 percent of class meetings, the faculty member can file a written report which may result in de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation.

PLNU highly recommends that DRC students speak with their professors during the first two weeks of each semester about the applicability of their AP in that particular course and/or if they do not desire to take advantage of some or all of the elements of their AP in that course.

## PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all **synchronous** class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions (virtual or face-to-face), the faculty member will issue a written warning of deenrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation. In some courses, a portion of the credit hour content will be delivered **asynchronously** and attendance will be determined by submitting the assignments by the posted due dates. See <u>Academic Policies</u> in the Undergraduate Academic Catalog. If absences exceed these limits but are due to university excused health issues, an exception will be granted.

## **Asynchronous Attendance/Participation Definition**

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date. Failure to meet these standards will result in an absence for that day. Instructors will determine how many asynchronous attendance days are required each week.
