Course Description and Purpose: This course is designed to open a conversation (that will hopefully last a lifetime) about the Old Testament (also known as the Hebrew Bible). The class provides an introduction to (1) the literature/content of the Old Testament in its social, historical, literary, and theological contexts; and (2) the critical study of the Old Testament. Along these lines, this course is designed as a journey, which serves to introduce the student to the basic content of the divine-human drama that unfolds within the pages of the Bible and to equip the student with the foundational tools and skills to continue the dialogue with that drama throughout his or her life. Cognitive development will be encouraged through textbook readings, classroom discussions/lectures, and periodic examinations. Social development will be encouraged through small group discussions and exercises as well as through the relating of biblical concepts to contemporary social issues. Spiritual development will be encouraged through a dialogue with the dynamic faith of the Christian Scripture, a faith that grew out of the community of believers and continues to challenge and shape that community in contemporary settings.

Course Learning Outcomes (School of Theology and Christian Ministry): The student who successfully completes this course will be able to:

- 2. Articulate the unity of the Old Testament in its canonical context within the diverse literature of the Christian canon.
- 3. Articulate and appreciate the ways in which the Bible, understood as given by divine inspiration, functions as the church's central norm for Christian discipleship, faith and practice; and,
- 4. Articulate the basic content of the books of the Old Testament and the methods appropriate to the interpretation of those books.

Course Requirements:

- Quiz on the Books of the Old Testament: This will take place in class.
- Class Participation and Attendance: Regular attendance in class is required, and worth 20% of the final grade. You are allowed three absences, after which each absence will result in a 10% reduction of your attendance grade, which is equivalent to 2% of your total grade. The only excused absences are those involving a your hospitalization, a death in your family, or an illness or condition approved as an accommodation through the PLNU Educational Access Center. NOTE: Giving false information on the daily roll sheet (i.e. signing someone else in or having someone else sign you in) is an act of cheating that is equal to cheating on an exam. It will subject you to the academic dishonesty penalties of the university, including failure of this course and possible expulsion from theuniversity. If you are aware that you will be unable to attend class, let me know beforehand, and I will use zoom so that you can participate remotely, in which case you will be considered present.
- **Book Review Essay**: For this assignment, you will write a review of *A Teachers Guide to Understanding the Scriptures* by PLNU Prof. Emeritus Samuel Powell. This review should include a summary and assessment of the book, including reference to ideas and themes we have discussed throughout the semester. It should be 2-3 pages in length and will be graded for accuracy of summary, depth of assessment and clarity of writing. See attached rubric for additional grading criteria.
- **Group Presentations**: All students will be required to contribute to a group presentation on one book of the OT. These groups will coincide with discussion groups. Complete directions are available within the appropriate Module.
- **Group Discussions**: Multiple assignments over the course of the semester will involve your participation in discussions with your presentation group. Responses to all members of your small group are required for full credit.
- **Midterm and Final Exam**: There will be two major exams--a midterm and final. The midterm will cover material from the first half of the semester and the final material from the entire semester. You will have several days and have access to all course materials, including notes from lectures, all assigned readings and videos. Use of AI and plagiarism are both strictly forbidden and will result in a failing grade on the exam and a report to the provost. Canvas is VERY good at identifying both, and it's typically obvious to your professor, even when students make extensive changes to cover their tracks, so it's not worth trying. Besides, you are being given open access to all course materials, so there is no reason for cheating. And plagiarism is actually

very easy to avoid--you simply need to cite the sources you have used for your answers. I'm not particular about what citation format you use, and am happy to talk with students who need instruction for doing this properly.
