COURSE DESCRIPTION

Introduction to the techniques used in the teaching and performance of the major woodwind instruments.

COURSE LEARNING OUTCOMES

This course will present the students with an introduction to the major woodwind instruments of the wind ensemble and symphony orchestra. While the limitations of a one-semester course will not allow the student to become technically proficient at every instrument, the materials and activities of the course will provide the student with the necessary knowledge and skills to confidently utilize woodwind instruments in ensemble and lesson settings.

STUDENT LEARNING OUTCOMES

- 1. The students will gain a basic understanding of the background and technical requirements of all
 - standard members of the woodwind family, and will have hands-on experience with each instrument.
- 2. The student will receive in-depth experience with the clarinet as a model for the embouchure and
 - technical skills that apply to all single-reed woodwind instruments.

- 3. The student will gain first-hand knowledge of one instrument in the saxophone family and one double reed instrument, while learning about the other members of those families
- 4. The student will receive in-depth experience with the flute.
- 5. The student will be provided with pedagogical approaches to assist future elementary, middle, or high school students in both private lesson and ensemble settings.

REQUIRED TEXTS AND RECOMMENDED STUDY RESOURCES

Students will not be required to purchase the texts in this series, but a full set will be available for reference in the instructor's office. Further purchasing information will be provided to any interested student.

Instruments for the class will be provided from the PLNU instrument collection and loaned to the students for practice outside of class. Each student will fill out a comprehensive PLNU Instrument Borrowing Contract at the beginning of the semester, and will be expected to adhere to the terms of this agreement, which may institute financial penalties for any damages done to a University instrument. The student will be responsible for bringing the appropriate instrument or instruments to each class session.

Students should bring a three-ring binder to class in order to collect class handouts as compiled by the instructor. By the conclusion of the course, each student will have complete fingering charts and other pertinent information for the instruments of the woodwind family. This maybe done electronically in google drive or similar format.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1 unit class delivered over 14 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework.

ASSESSMENT AND GRADING

Skills Ouizzes will count for 400 points, or 4 guizzes worth 100 points each.

In woodwind methods, we will cover a variety of topics, some of which you may find triggering. These topics include [list topics]. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center.
