Course Description

At its core, music is an authentic expression that has the transcendent power to connect with masses of diverse people across all demographics. This type of "Popular" music not only speaks for culture, but can shape it as well. Understanding the music of the masses helps us understand the perspectives of their day, for better or for worse, and understanding the pop music art form with its perpetual changes over time, greatly informs musicians in their own artistic journey.

This course examines the historical, cultural, commercial, technological, and artistic significance of popular music in the United States from the late nineteenth century to the present. We will focus on the musical, social, political, and economic dimensions of genres

ranging from ragtime to hip-hop. An interactive textbook provides modules with readings, videos, and listening playlists. There will be quizzes for each module, writing assignments, a midterm, and a final. As Popular Music History is still being written, weekly presentations will be given comparing current events with their historical roots, providing a living context and application for the subject.

By the end of the semester the student will be able to:

- Articulate the landmark events and general overview of the history of Pop Music to gain a broader understanding and appreciation for its impact on culture and society.
- Engage the world of Popular Music through the lenses of its diverse historical, cultural, technological, sociological, and commercial roots.
- Develop an understanding of technological innovation in music and its impact on the art form.
