Course Description

Faith, Life and Music is a capstone course required of all music majors intended to assist students with the transition to life-after-graduation. Along the way, we will explore 1) details of developing different kinds of music careers and the scope of particular industry segments, 2) reflection, inventory, and assessment of the skills, growth, and development that have occurred while at PLNU and how these elements will apply in the future, and 3) the application of our Christian faith to music, life, and our profession.

Program and Course Learning Outcomes

1. Students will develop self-knowledge of their abilities, goals and direction resulting in a clear articulation of aligned role-path-purpose that will both define a higher mission and describe concrete steps (immediate and long-term) to achieve their purpose.

- 2. Students will articulate an understanding of the professional roles filled by career musicians, and the career paths that customarily prepare for those roles.
- 3. Students will be able to articulate how the call to be salt and light applies to their professional pursuits.

PLNU Academic Accommodations Policy

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment.
