Course Description

Within the context of Christian origins, an overview of the canonical literature of the New Testament with special attention to its literary history and theological themes.

PROGRAM GOAL

PLNU's Christian studies programs equip you with a foundational knowledge of Scripture and theology, as well as the practical experience essential for ministry and service, enabling you to courageously confront the problems facing our world today.

The following student learning outcomes will be achieved by this course:

- 1. Identify the historical contexts of the New Testament. $^{\hbox{\scriptsize GELO}}$ 1a, 3
- 2. Articulate the unity of the New Testament in its canonical context within the diverse literature of the Christian canon. ^{GELO 1d, 3}
- 3. Articulate and appreciate the ways in which the Bible, understood as given by divine inspiration, functions as the church's central norm for Christian discipleship, faith, and practice. $^{\rm GELO~1d,~3}$
- 4. Articulate the basic content of the books of the New Testament and the methods appropriate to the interpretation of those books. ^{GELO 1a, 3}

Program Learning Outcomes

- 1. To help students appreciate and understand Christian history, theology, and spirituality from the perspective of the biblical, historical Christian faith;
- 2. To create opportunities for students to apply and integrate classroom knowledge and principles to in-service training experiences in local churches, cross-cultural settings, and missions;
- 3. To prepare students to pursue the study of philosophy, theology, or religion in a graduate school or seminary;
- 4. To educate students to be "practical thinkers" and "thinking practitioners."

- 1. Learning, Informed by our Faith in Christ
 - Students will acquire knowledge of human cultures and the physical and natural world while developing skills and habits of the mind that foster lifelong learning.
- 2. Growing, In a Christ-Centered Faith Community

- 3. Serving, In a Context of Christian Faith
 - Students will serve locally and/or globally in vocational and social settings.

Assessment and Grading

Weighted Grades

The following components will be present in the course to assess your learning:

- 1. **Readings** The New Testament is the primary text for this course. All readings are required. It is important to keep up with the readings on a session-by-session basis or the information will quickly become overwhelming. There will be both weekly quizzes ("Celebrations of Learning") and discussion forums aligned to the reading each week.
- 2. **Discussions** will be based on your observations from the assigned reading. **Discussions will make up 30% of your overall grade**.

- Your initial post will contain three significant statements or points made or things you observed in the readings themselves (whether the biblical passages or textbooks) with an explanation for each of them and why you thought they were significant. **Note:** the initial post should be a total of **400 words** for all three observations.
- Responses are required by at least two classmates to thoughtfully engage with their posts and offer some responses that examine their observations ask questions of them or even add to what they observed. **Note:** responses should be **200 words in** total for the two responses combined.
- 3. Celebrations of Learning (a.k.a. reading guizzes) Quizzes will make up 50% of your overall grade. These will cover various reading assignments and associated class lectures. There are "Celebrations" each week (often called, erroneously, "quizzes":-)) and study guides ("Party Favors"!) will be provided.
- 4. **Assignments** will include Pre-lecture reflections, the end-of-course evaluation, a chance for extra credit and the Final Celebration of Learning will be a short reflective essay (a.k.a. final exam) at the end of the course. Final Celebration will make up 20% of your overall grade.

Student grades for assignments will be posted in the Canvas gradebook no later than midnight on Tuesday of each week beginning in Week Two of this course. It is important to read the comments posted in the gradebook as these comments are intended to help students improve their work. Final grades will be posted by the due date as posted in the Academic Calendar.

Final Examination Policy

Successful completion of this class requires taking the final examination on its scheduled day. If you find yourself scheduled for three (3) or more final examinations on the same day, you are authorized to contact each professor to arrange a different time for **one** of those exams. However, unless you have three (3) or more exams on the same day, no requests for alternative final examinations will be granted.

Incompletes and Late Assignments

All assignments are to be submitted by the due dates. There will be a 10% reduction of possible points for **each day** an assignment is late and assignments will **not be** accepted for credit four days after the due date. If missing assignments result in the failure to meet learning outcomes, students may receive a letter grade reduction on the final grade in addition to the loss of points for missing work. Assignments will be considered late if posted after the due date and time using Pacific Standard Time. No assignments will be accepted after midnight on Sunday night, the last day of class.

Exceptions for extenuating circumstances must be pre-approved by the instructor and the program director.

PLNU Attendance and Participation Policy

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

Students who anticipate being absent for an entire week of a course should contact the instructor in advance for approval and make arrangements to complete the required coursework and/or alternative assignments assigned at the discretion of the instructor. Synchronous Attendance/Participation Definition

For synchronous courses that have specific scheduled meeting times (including in-person, hybrid, and synchronous online courses), absences are counted from the first official meeting of the class regardless of the date of the student's enrollment. Note: For synchronous courses with an online asynchronous week, refer to the Online Asynchronous Class Attendance policy listed below.

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty members within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

- 1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 - 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 - 2. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

Additionally, students are required to have headphone speakers, microphone, or webcams compatible with their computer available to use.
