Course Description

Sociology presents a fundamentally different perspective on our human world than most Americans typically engage with: one that emphasizes our connections and relationships with other people. In this course, you will begin to examine the role that institutions, power, and our own social interpretations play in shaping our lives. We will examine the constraints and advantages that come with belonging to social groups (including those created by race, gender, age, social-economic status, and religion), and we will wrestle with conceptions of social structure, culture, and deviance.

1. Critically discuss major theoretical perspectives, such as conflict theory, structural functionalism, and symbolic interactionism. (GELO 2c)
2. Identify and critique various social structures, particularly those resulting in inequality and injustice. (GELO 2c)
3. Evaluate and apply social science data to inform decisions of everyday life. (GELO 2c)

4. Describe and exemplify the relationship between our Christian faith and human actions.
 5. Apply service-minded sociological concepts to specific need areas in our communities. (GELO 2c)

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Submitting an assignment
- Taking an exam
- Participating in online labs

- Initiating contact with faculty members within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 2. Asynchronous Courses: All class meetings are asynchronous.
 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
