Course Description

<u>LECTURE</u>: Detailed analysis of protein and membrane structure. Includes quantitative approaches to the study of enzymes, catalytic mechanisms of enzymes, and a survey of the major metabolic pathways of carbohydrates, lipids, amino acids and nucleic acids. Course includes one three-hour laboratory each week. <u>LAB</u>: An inquiry-based laboratory that is a co- requisite for <u>CHE/BIO 4050</u>. Letter graded.

Program Learning Outcomes for Chemistry as applied to this course:

- Apply key concepts and principles in analytical chemistry, biochemistry, inorganic chemistry, organic chemistry, and physical chemistry.
- Use standard instrumentation and laboratory equipment to conduct scientific experiments and perform chemical characterization and analyses.
- Be prepared for post graduate studies or a science-related career.

Course Learning Outcomes

At the end of this course, you will be able to:

- Recognize and reproduce the structures of the 20 amino acids
- Apply specific properties of these amino acids to protein folding and activity
- Identify and evaluate enzymatic active sites based on appropriate chemical reactivity
- Apply specific chemical reactions to the processes of metabolism and photosynthesis
- Recognize how and when cells must degrade or apoptosize
- Outline defining mechanisms and lifecycles of several representative viruses

Course Credit Hour Information

PLNU Academic Accommodations Policy
