COURSE DESCRIPTION

Independent investigation, under the supervision of a member of the biology faculty. May be repeated for a total of six units, but no more three units may count toward upper-division requirements for graduation. Offered every year. Prerequisite(s): Junior or Senior standing and consent of instructor.

Course Learning Outcomes: Research students will be able to

- 1. apply skills and knowledge learned in science courses to research situations.
- 2. reinforce and expand previous conceptual learning through research experiences.

Evaluation and Grading: Your grade will be based on hours worked, work ethic, and a final report, as follows.

- Hours worked: 25%.
- You must keep track of your hours worked a report the information to your faculty mentor.
- Work ethic: 50% (Work ethic includes effort, promptness, collegiality, and care in completing experiments.)
- Final report: 25% (This can take various forms depending on your faculty mentor. It could include a lab notebook, a poster presentation, or a short paper.)

PLNU Academic Accommodations Policy
