#### **ARTIFICAL INTELLIGENCE (AI) POLICY**

AI tools (e.g., ChatGPT, Gemini, Perplexity) are based on predictive machine learning and not true 'intelligence', thus the information it gives you may be inaccurate and must be fact-checked! Use of AI for assignments must be acknowledged and cited using APA citation format for AI attribution. If you have any doubts about using AI, please ask the instructor.

I acknowledge that each of you comes to PLNU with your own unique life experiences which contribute to the way you perceive various types of information. In BIO4010/4010L (Vertebrate Biology) all of the class content, including that which may be intellectually or emotionally challenging, has been intentionally designed to achieve the learning goals for this course. If this occurs, I encourage you to come talk to me or your friends or family about it. Class topics are addressed for the sole purpose of expanding your intellectual engagement in the area of vertebrate biology and I will support you throughout your learning in this course.

#### TRIGGER WARNING

It is possible that these topics and activities may be a trigger for you. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of vertebrate biology and I will support you throughout your learning in this course.
