COURSE DESCRIPTION

This capstone course focuses on a thorough understanding of the analytical techniques and skills necessary to identify, develop, and implement successful business strategies. Utilizing an intensive case-study approach, students demonstrate an understanding of the main elements of the strategic management process, including a semester-long detailed strategic plan analysis of an existing corporation. In addition, the course integrates knowledge and skills students have mastered in previous courses.

COURSE LEARNING OUTCOMES

Upon completion of this course, students will be able to:

1. Analyze and evaluate the strategies of an organization by integrating appropriate insights from the core business disciplines (PLO 1, 2 & 3).
2. Formulate a strategy for an organization considering strategic options, assessment of alternatives, and emerging market conditions (PLO 2 & 3).
3. Present the results of a strategic evaluation in a professional and concise manner (PLO 6).
4. Construct strategies and structures that reflect ethical principles, company values, and socially responsible management practices (PLO 5).
5. Collaborate effectively in a team to analyze current challenges in business (PLO 7).

COURSE MODALITY DEFINITIONS

1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.

- a. Synchronous Courses: At least one class meeting takes place at a designated time.
 - b. Asynchronous Courses: All class meetings are asynchronous.
2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

PLNU ATTENDANCE AND PARTICIPATION POLICY

Face-to-Face MBA/MAOL Courses:

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an “F” grade.

Students who anticipate being absent for an entire week of a course should contact the instructor in advance for approval and make arrangements to complete the required coursework and/or alternative assignments assigned at the discretion of the instructor. - Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

COURSE SCHEDULE AND ASSIGNMENTS

- **The Business Strategy Game (400 pts):** You will work in teams to manage a global athletic footwear company competing in a dynamic marketplace. Together, you'll make strategic decisions in operations, marketing, finance, and CSR across multiple simulated years. Your decisions will be benchmarked against those of competitors on performance metrics such as earnings per share, return on equity, stock price, and image rating.
 - **Overall Company Performance (300 pts):** The majority of your grade is based on how well your company performs in the simulation. Success will be measured using the BSG's balanced scorecard, which includes profitability, stock performance, brand image, and financial health.
 - **Quiz 1 (10 pts) & Quiz 2 (20 pts):** These online quizzes test your understanding of the simulation mechanics and rules. Completing them early and scoring well will give your team a strong foundation for effective competition.

- **Co-Manager Questions (30 pts):** Each team's Co-Managers will collaborate to respond to reflection questions throughout the simulation, ensuring strategic thinking, accountability, and learning.
- **Performance on 3-Year Strategic Plan (30 pts):** Your team will create and submit a forward-looking strategic plan. You'll be graded on the clarity, realism, and execution of your plan over the next three rounds of play.
- **Peer Evaluation (10 pts):** Teamwork matters. You'll evaluate your teammates' contributions, and your peer scores will factor into your individual grade to ensure fair credit is given.
- **Chapter Quizzes (100 pts):** Short quizzes on the textbook chapters will reinforce key concepts and help prepare you for in-class case discussions and simulation decisions.
- **Case Study Reflections & Discussions (250 pts)**
 - **Case Study Reflection Questions (125 pts):** Before each case discussion, you'll complete a short individual assignment responding to key questions about the case. These reflections will help you think critically, apply course concepts, and come prepared to contribute meaningfully to the discussion. Your responses will be graded for thoughtful engagement, not perfection.
 - **Case Study Discussions (125 pts):** You will participate in weekly online discussions centered around real-world business cases. Each week, one team will present their case analysis, and one team will lead the discussion as the Challenge Team. You are expected to contribute thoughtful responses to the Challenge Team's questions and engage with your classmates' insights. These discussions are a vital part of your learning, modeling the kind of strategic debate found in real executive teams.
- **Case Study Presentation (Group) (50 pts):** Each team will lead one case study by preparing a short video presentation analyzing the company's strategic situation. Your presentation should apply relevant frameworks, highlight key issues, and propose strategic recommendations. These presentations will spark discussion and demonstrate your team's ability to think like strategic consultants. Each team is responsible for one case during the course.
- **Case Study Challenge (Group) (50 pts):** Each team will serve as the challenger for one case by preparing thoughtful, strategic questions based on their own independent analysis. As challengers, your team will post your questions and actively lead the online discussion, pushing your classmates to think deeper about the issues. You'll be graded on the quality of your questions and your ability to facilitate a robust, insightful dialogue.
- **Final Strategic Leadership Report and Board Presentation (150 pts):** This capstone assignment challenges you to step into the role of a strategic leader, drawing from your experience in the Business Strategy Game (BSG). You will prepare a high-level written report and a professional video presentation as if delivering insights to your company's Board of Directors. Your Strategic Leadership Report (100 points) will demonstrate your ability to apply core frameworks, analyze performance, reflect on key decisions, and recommend a forward-looking strategy. Your Video Presentation (50 points) will showcase your executive communication skills and summarize the strategic journey of your company. This assignment is your opportunity to demonstrate mastery of strategic management—by not just reporting what you did, but showing how you *thought* as a leader.
