Course Description ★

With this course we hope to learn not only ancient history as told by ancient historians; but also to think about how the discipline of history was perceived and practiced in the ancient Mediterranean world. The course is heavily oriented toward reading and discussion.

Program and Course Learning Outcomes ★

- 1. Students will be able to evaluate and interpret various types of primary sources.
- 2. Students will be able to identify the roots of modern historiography in ancient sources.
- 3. Students will be able to identify the most distinctive people and events written about in the ancient history of West Asia and the Eastern Mediterranean.
- 4. Students will be able to articulate the differences between historiographical reasonableness and scientific/philosophical rationality.

Students are responsible for having the required course textbooks prior to the first day of class.

Grading:

Students will bring notebooks to class every day and be asked to read from them to the class. Students are responsible for all emails sent by the professor to PLNU email addresses.

Three Presentations:

In concert with your professor, pick a person, event, or situation of some sort (a river, the delta, a port, town, a painting, etc.) related to three of the books we are discussing.

You and your professor will agree on a topic.

You will orally present in class at the document projector a 10 minute presentation.

The presentation will include:

- 1. A handwritten paragraph (from each student) stating the topic, the importance of the topic, and information to support the importance. The importance of the topic is where presenters must be most thoughtful and creative, relating a person, place, or event to big issues discussed in class.
- 2. Presentations include a hand-drawn map (from each student) that relates directly to the topic.

Presentations will be graded on the basis of evident effort.
