# **Course Description**

Hands-on production of an online, student-run media outlet providing both a training ground for students interested in gaining experience in various aspects of digital media as well as high quality news source for PLNU. Open to all students. JRN 2015, WRI 2016, JRN 2017, JRN2018 and COM 2075 may be repeated up to a combined total of eight units.

This course is conducted as a workshop to develop stories and media for lomabeat.com. Expectations of a workshop course include bringing ideas and media to share, giving and receiving feedback, and completing media stories with the possibility of getting published publicly with your name attached. Ou The instructor will help guide you while you work on projects and offer accompanying training and advice as needed to complete your work.

#### **Course Credit Hour Information**

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 2-unit class delivered over 15 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 75 total hours meeting the course learning outcomes. The time estimations are provided in the Canvas modules.

# **Assessment and Grading**

As a workshop class, the grade is based on the number of pieces you complete for *The Point's* social media accounts. The goal of the course is to experience the creative process of producing different types of media for a specific outlet. The number and type of stories will be up to you and the discretion of the editorial staff of *The Point* or other media outlet. The following content types are valid for pitching, submission and completion:

- Lead photo with caption
- Photo series with captions

## **Final Examination Policy**

Successful completion of this class requires taking the final examination on its scheduled day. The final examination schedule is posted on the <u>Traditional Undergraduate Records: Final Exam Schedules</u> site. If you find yourself scheduled for three (3) or more final examinations on the same day, you are authorized to contact each professor to arrange a different time for <u>one</u> of those exams. # **Content Warning**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive various types of information. In this course, all of the class content, including that which may be intellectually or emotionally challenging, has been intentionally curated to achieve the learning goals for this course. The decision to include such material is not taken lightly. If you encounter a topic that is intellectually challenging for you, it can manifest in feelings of discomfort and upset. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of multimedia production, and I will support you throughout your learning in this course.

#### **Incompletes and Late Assignments**

All assignments are to be submitted/turned in by the beginning of the class session when they are due.

Assignments submitted after the deadline will receive a **10% deduction for each calendar day late,** up to a **maximum penalty of 50%.** Incompletes will only be assigned in extremely unusual circumstances.

**Example:** An assignment submitted 1 day late will lose 10%, 3 days late 30%, and 5 or more days late will lose 50% (maximum).

This means you can still receive credit for your work even if it's significantly late, but the highest deduction applied will not exceed 50% of the assignment grade, except for in an unusual circumstance.

Canvas may automatically mark the late assignment as zero. **Please do not be alarmed if this happens.** <u>I</u> will go through each assignment later and change the grade to reflect the 50% maximum penalty.

I understand that life happens, and unexpected situations may arise. Please communicate with me as early as possible if you anticipate not being able to turn in the assignment on time.
