COURSE DESCRIPTION

Instruction and participation in the basic skills of surfing and rough water safety. Each student will demonstrate rough water swim, board control and an understanding of wave characteristics. Offered on a Quad basis.

COURSE LEARNING OUTCOMES

- 1. The student will state the terms of surfing, the aspects of rough water safety, care of equipment and skill knowledge.
- 2. The student will chart a weekly surfing workout.
- 3. The student will demonstrate surfing skills of:
 - A. duck diving or turning turtle
 - B. paddling
 - C. dry land pop-ups
 - D. Sitting and turning on the board
 - E. Catching waves
 - F. pop-ups

Students will develop an understanding of self that fosters personal well-being.

FINAL EXAMINATION POLICY

Successful completion of this class requires taking the final examination on its scheduled day. Students with disabilities may request course-related accommodations by contacting the Educational Access Center (EAC), located in the Bond Academic Center (EAC@pointloma.edu or 619-849-2533). Once a student's eligibility for an accommodation has been determined, the EAC will work with the student to create an Accommodation Plan (AP) that outlines allowed accommodations. Professors are able to view a student's approved accommodations through Accommodate.

PLNU highly recommends that students speak with their professors during the first two weeks of each semester/term about the implementation of their AP in that particular course. Accommodations are not retroactive so clarifying with the professor at the outset is one of the best ways to promote positive academic outcomes.

Students who need accommodations for a disability should contact the EAC as early as possible (i.e., ideally before the beginning of the semester) to assure appropriate accommodations can be provided. It is the student's responsibility to make the first contact with the EAC. Students cannot assume that because they had accommodations in the past, their eligibility at PLNU is automatic. PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

PLNU Course Modality Definitions

- **1.** Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - **a.** Synchronous Courses: At least one class meeting takes place at a designated time.
 - **b.** Asynchronous Courses: All class meetings are asynchronous.
- **2.** Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

In some courses, a portion of the credit hour content will be delivered asynchronously and attendance will be determined by submitting the assignments by the posted due dates. See Academic Policies in the Undergraduate Academic Catalog.

Asynchronous Attendance/Participation Definition

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date. Failure to meet these standards will result in an absence for that day. Instructors will determine how many asynchronous attendance days are required each week.

assistance of AI technologies. Violations of this policy will be treated as breaches of academic integrity.
