Course Description

This course introduces students to foundational technologies involved in professional music production, performance, and analysis. We will discuss and engage in the terminology of technology, the best practices utilized within the industry, and the methodologies used to create and distribute music with digital tools.

By the end of the course, you will demonstrate through assignments, quizzes, and in-class activities that you have gained a basic understanding of Music Technology and have developed specific skills and competencies needed by music professionals, including:

- Employing proper terminology for the professional live audio and recording studio environment
- Best practices regarding cable management, microphone technique, and stage plotting.
- Utilization of Recording, Editing, and Mixing tools within a Digital Audio Workstation.
