Course Description

This course focuses on the history, concepts, and techniques of the modern digital audio workstation. We will discuss and practice the technology, terminology, and methodology involved in creating music with digital tools.

- Employ proper terminology in the studio environment.
- Demonstrate best practices for outfitting a home recording studio.
- Demonstrate a useful understanding of the Recording, Editing, and Software Instrument tools within the Logic Pro X digital audio workstation.
- Employ various plug-ins, signal processors, and effects to augment the quality of a recording.
- Display a working aptitude of Logic Pro X equivalent to that of an Apple Certified Professional.
- Demonstrate the ability to record, edit, mix, and bounce a multi-track session in real-world production environment.

- Logic Pro X audio software. The Music Lab computers are equipped with Logic Pro X and are available for use during normal building hours.

PLNU Academic Accommodations Policy

PLNU is committed to providing equal opportunity for participation in all its programs, services, and activities in accordance with the Americans with Disabilities Act (ADA).
