Class instruction for the student without prior study; emphasizes functional keyboard skills such as sight reading, harmonization, improvisation, and solo and ensemble playing. Appropriate for Music majors who must prepare for the proficiency exam.

- 1. Knowing how to read/play music, including musical symbols, the notes on the grand staff, and understanding patterns of intervals, through playing and written tests
- 2. Knowing keyboard topography, basic technique, and proper posture and hand position through performing of various exercises and repertoire
- 3. Knowing basic concepts of pulse, rhythm, and meter through various exercises
- 4. Knowing all major key signatures through written tests
- 5. Performing selected major and minor pentascales through playing tests
- 6. Performing selected major scales (tetrachord position) through playing tests

Practice

Students are required to practice to pass this course. Cramming for piano is impossible since it requires constant skill development and muscle memory. Most students will need about 30 minutes of practice for 5 days a week. Some will need less and some will need more.

Final Examination Policy

Successful completion of this class requires taking the final examination on its scheduled day. The final examination schedule is posted on the <u>Traditional Undergraduate Records: Final Exam Schedules</u> site. If you find yourself scheduled for three (3) or more final examinations on the same day, you are authorized to contact each professor to arrange a different time for <u>one</u> of those exams. However, unless you have three (3) or more exams on the same day, no requests for alternative final examinations will be granted.

Incompletes and Late Assignments

All assignments are to be submitted/turned in by the beginning of the class session when they are due—including assignments posted in Canvas. Incompletes will only be assigned in extremely unusual circumstances. Late work, should it be accepted, will lose 10% per calendar day. Incomplete assignments will be counted as late.

There will be no make-ups for missed in-class quizzes, performances or exams. The instructor may offer second attempts for poor grades on quizzes, exams, or assignments. The instructor will make it clear which assignments are qualified for a second attempt, and the requirements that go with it. The new score will be an average of the first and second attempts.
