Point Loma Nazarene University faculty are committed to helping create a safe and hospitable learning environment for all students. and clarity of language, we mark ourselves as serious and respectful scholars, and we model the Christ-like quality of hospitality.

PLNU Attendance and Participation Policy☼

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement.
