Course Description

Assessment and Grading

Graded Course Components

Online Discussions & Group Work: Participation in discussion board forums is intended to promote collaboration between participants. These online conversations will be based primarily on related assigned readings or content in the course. As a guideline, plan to contribute at least two substantive posts per day during active discussions. A substantive post contains material related to the topic, application to your teaching practice, and/or extends learning in a meaningful way. It is expected that you read all posts in each discussion board forum. **Discussions & Group Work represent 30% of the overall course grade.**

Assignments: Assignments are designed throughout the course for the application of learning aligned to the course content. **Assignments represent 25% of the overall course grade.**

Reading Quizzes: Weekly quizzes are given on reading on the assigned reading each week. **Quizzes represent 10% of the overall course grade.**

Signature Assignment: The final assignment for this course is a theoretical framework paper that will allow you to demonstrate and apply your understanding of child and adolescent development. **Final Project represents 35% of the overall course grade.**

Course Modality Definitions
