**COURSE DESCRIPTION**

**Motor Development:** A study of motor, physical, and neuromuscular development from prenatal periods to old age.

**Motor Learning:** A study of factors involved in the learning and performance of motor skills. Laboratory experiences included.

**COURSE LEARNING OUTCOMES for Motor Development**

After successfully completing this course, students will:

1. know and understand the developmental phases/stages of human physical development from prenatal periods to old age.
2. recognize and evaluate mature and immature movement patterns.
3. know and understand factors influencing human physical growth and development such as; social, emotional and environmental factors, diseases and physical disabilities.
4. know and understand the impact of physical changes that occurs with growth, development, and age in the areas of mechanical and physiological aspects of motor

performance.

5. be able to identify differences and similarities of individuals and of genders.
6. be able to prescribe developmentally appropriate programs for lifelong human development.
7. understand the importance of “perceptions of self” as they relate to the learning of motor skills. This includes the differentiation of self-concept, self-esteem, self-confidence, and self-image as components of one’s perception of self.

### **METHODS for Motor Development**

1. Class lecture and discussion will prepare students for laboratory experiences at the on-campus Early Childhood Center which are the heart of this portion of the course.
2. Group Project  
Working in small groups, students will first assess preschooler’s current motor development status, and then devise a plan to move them to the next stage of development. Groups will then share their findings with the rest of the class emphasizing similarities and differences between genders, ages, sibling order and environment. The development of self (confidence, image, esteem) is emphasized in program development and evaluation.

Motor Development content is shared through lecture and discussion.

Understanding of the material is checked by having the students take a recall exam.

Application of the learned material takes place at the Early Learning Childhood Center Small group work helps students practice collaboration and stimulates creativity.

Class presentations provide an opportunity for the group to synthesize the material before sharing it with their peers as well as practicing professional standards for oral presentations and the use of technology to enhance the understanding of the audience.
