Course Description

Students will identify basics of strategic and operations planning, finance, human resources, communications, planning and control systems. Topics include strategic planning, innovation, and the effectiveness of operations and systems management.

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

### Course Modality Definitions

  3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
