## Course Description

Supervised therapy experience in applied psychotherapeutic techniques at an external agency. This course provides support, supervision, and consultation for students' training at their practicum site. A total of 700 hours, 300 of which are face-to-face direct service, must be accrued throughout the practicum course sequence. Students must be training at an approved site to be enrolled in this course. Credit/No Credit. **NOTE:** Students are responsible to have the required course textbooks prior to the first day of class. Students are also encouraged to begin reading the books in preparation for the class as soon as possible.

## Assessment and Grading



Grading is on a CR/NC basis. To pass the class, you must attend and participate. Assignments will be evaluated based on competency level and must meet minimum standards to achieve a passing grade (CR). If the submitted assignment is deemed to be below minimum competency level, the student may resubmit the assignment. All assignments must meet minimum standards to receive a CR for the final course grade. You must be engaged, participate in discussion, complete any assigned readings, and be ready to give feedback and support to your classmates.

Several of the requirements from this class along with projects in Clinical Practicum 2 and 3 will be integrated into a ***Clinical Portfolio project*** which will be presented at the end of the program.

1. **Attending Skills** -- Students will role-play and receive feedback from the group on basic attending skills (Ivey et al).
2. **Signature Theme Paper.** Students will write a reflection paper on their "Signature Theme," a dominant theme that significantly influences their emotional, relational, and spiritual lives. This paper will include an exploration of how this theme impacts their coping strategies, family history, and potential clinical work. Students will also complete the YSQ assessment, score it, and identify their top three schemas, which will serve as a tool for developing their Signature Theme. Then, note and discuss their top three schemas and how these relate/connect to their signature theme. The paper should be 5-7 pages long, formatted according to APA 7 student guidelines.
3. **Informed Consent.** Students will bring examples from their internship sites regarding their *Informed Consent Form* paperwork that clients fill out before receiving services. Students will write and develop their own *Informed Consent Form* and discuss it with their group during the last weeks of class, along with a self-evaluation of their attending skills, self of therapist awareness, and examples of diversity issues noted in their internship.
4. **Video and Case Presentations**

Students will be required to show one video recording of a session during the term. The video should include a demonstration of the attending skills learned in class. Instructors will pass around a sign up sheet and students will sign up for a day to show their video and talk through the case, typically in the second half of the semester.
5. **Participation**

Class participation is necessary to demonstrate familiarity with the assignments and the ability to transfer theory into practice, especially during your practicum. The following criteria will be used to evaluate participation.

Participation in discussions and Practicum

- o Appropriateness of comments
- o Comments useful for clarification or meaningful contribution to the class



- o Willingness to participate in exercises and simulations
- o Sensitivity to participation of others in the class; avoids dominating discussions

Class participation demonstrates understanding of concepts reviewed

## 6. Training Paperwork

Students will submit training paperwork, including the initial BBS Supervisor Agreement and Student Training Agreement (both at the beginning of the course) and Hours Logs and Supervisor Evaluation of Student (at the conclusion of the course). **All paperwork must be completed and submitted to receive a CR. This is very important!**

## PLNU Course Modality Definitions

1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
  - Synchronous Courses: At least one class meeting takes place at a designated time.
  - Asynchronous Courses: All class meetings are asynchronous.
2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.



3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

## PLNU Attendance

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

PLNU Policy: If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent (equivalent to two (2) classes in the MACC program), the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

Note: If a student incurs a third absence, they may petition the faculty to remain enrolled in class. The faculty will provide a make up assignment proportionate in length and difficulty to the class missed. This third absence may also result in a referral to the Student Development Committee.

In addition to the university policy, 10% of your course grade will reflect your attendance. Coming to class is mandatory and expected. As extenuating circumstances may happen that prevent you from attending class, a student may incur one absence without losing points. Each subsequent absence will drop this portion of the grade by 5% of the total course points (up to 10%). Note: absences are not categorized as excused or unexcused.

Attending class on time is essential to promote a respectful and professional learning environment. Arriving to class more than 15 minutes late is counted as a tardy. Two tardies count as one absence. Arriving 30 minutes or more late to a class will be considered an absence.
