Course Description

A study of intercultural principles, processes, and topics including; verbal and nonverbal communication, perception, cultural values and expectations, and media impact.

**and more:** In this course, we will be studying the complex and interdependent relationship between communication and culture. Through observation, discussion, and application, we will learn how communication is influenced by culture and how culture is created and sustained through communication. In this class, you will build a foundation of intercultural communication flexibility so that you will be better prepared to interact with others in diverse contexts.

### Course Learning Outcomes

By the end of the course, you will be able to:

1. Identify your own cultural identities and analyze how people's culture(s) affect beliefs, values, perceptions, assumptions and communication styles.
  2. Discuss the role of cultural biases (stereotyping, racism, ethnocentrism) in disrupting the development of intercultural competence and develop strategies for navigating these biases in communication interactions.
  3. Demonstrate communication skills that improve competence in intercultural communication.
  4. Explain how individuals express, produce, and negotiate culture through communication.
  5. Analyze the role of cultural patterns and verbal/nonverbal codes in the development of intercultural interpersonal relationships.

### Incompletes and Late Assignments

All assignments are to be submitted/turned in by the assignment due date on Canvas. Please follow all due-dates on Canvas closely. In general, late work will not be accepted in this course. Please do not attempt to submit assignments after the assignment has closed on Canvas. Please notify the instructor via email in advance of a due date if you are concerned that an illness or other personal hardship will prevent you from making an assignment deadline. It is much more possible to make adjustments in advance of an assignment due date, rather than after. Incompletes will only be assigned in extremely unusual circumstances.

There will be a 10% reduction of possible points for **each day** an assignment is late, and assignments will **not be** accepted for credit four days after the due date. If missing assignments result in the failure to meet learning outcomes, you may receive a letter grade reduction on the final grade in addition to the loss of points for missing work. ## PLNU Attendance and Participation Policy

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an “F” grade.

### *Synchronous Attendance/Participation Definition*

### *Online Asynchronous Attendance/Participation Definition*

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty members within the learning management system to discuss course content

**Note:** Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

## Course Modality Definitions

1. **Online Courses:** These are courses with class meetings where all instruction and interaction are fully online.
  1. **Synchronous Courses:** At least one class meeting takes place at a designated time.
  2. **Asynchronous Courses:** All class meetings are asynchronous.
2. **Hybrid Courses:** These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
3. **In-Person Courses:** These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
