# Incompletes and Late Assignments

All assignments are to be submitted/turned in by the beginning of the class session when they are due.

Assignments submitted after the deadline will receive a **10% deduction for each calendar day late**, up to a **maximum penalty of 50%**. Incompletes will only be assigned in extremely unusual circumstances.

***Example:** An assignment submitted 1 day late will lose 10%, 3 days late 30%, and 5 or more days late will lose 50% (maximum).*

This means you can still receive credit for your work even if it's significantly late, but the highest deduction applied will not exceed 50% of the assignment grade, except for in an unusual circumstance.

Canvas may automatically mark the late assignment as zero. **Please do not be alarmed if this happens. I will go through each assignment later and change the grade to reflect the 50% maximum penalty.**

I understand that life happens, and unexpected situations may arise. Please communicate with me as early as possible if you anticipate not being able to turn in the assignment on time.

## Assignments At-A-Glance

**Chapter Quizzes (300 points):** Open book reading quizzes will be conducted outside of class across chapters in *Introduction to Mass Communication: Media Literacy and Culture*, 12<sup>th</sup> ed., 2023. Baran. Quizzes will be assessed for a total of 30% of the final grade.

**Participation (150 points):** In-class engagement, Canvas discussions and participation in group projects are expected. Participation will be assessed for 15% of the final grade.

**YouTube Videos (150 points):** Students will produce a series of YouTube Videos. Two individual YouTube videos on a topic or theme of choice and two group videos on topics discussed in class. The projects will be assessed for 15% of the final grade.

**Timeline Reel (100 points):** Students will work in groups to produce a vertical video using the genre conventions of Instagram, YouTube Shorts or Tik Tok about the historical timeline for a particular medium. This project will be assessed for 10% of the final grade.

**Media Consumption & Reflections (100 points):** Students will track their own media consumption and respond with a written reflection. These assignments will be assessed collectively for 10% of the final grade.

**Industry Research (75 points):** Students will select a job within a media-related profession and identify skills, experiences and aptitudes needed to be considered for a particular role. Students will conduct peer reviews of these submissions and reflect on what they've learned. This work will be assessed collectively for 7.5% of the final grade.

**Content Creator Report (75 points):** Students will identify an influencer or content creator and report on various aspects of their work. Students will conduct peer review of these submissions and reflect on what they've learned. This work will be assessed collectively for 7.5% of the final grade.

**Media Fast (50 points):** Students will identify an area of media consumption to remove from their daily diet for an allotted amount of time. Written reflections on the experience will be assessed for 5% of the final grade.
