Students work in teams to produce television and film content for Point TV. May be repeated up to a total of three (3) units.

PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a) Synchronous Courses: At least one class meeting takes place at a designated time.
 - b) Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

ASSIGNMENTS AT-A-GLANCE

See Canvas for deadlines and assignment details.

TV Studio Production (400 points): Students will serve on the production crew for five TV studio productions. Written reflection on these experiences will be assessed for a total of 40% of the final grade.

Content Creation (300 points): Students will produce four pieces of content for Point TV's social media channels. Items published by PTV will receive full credit. These projects will be assessed for a total of 30% of the final grade.

Field Segment (100 points): Students will assist in the production of a field segment for the TV studio production. Written reflection on the experience will be assessed for a total of 10% of the final grade.

Final Presentation (100 points): A final presentation will be given to highlight the creative work produced during the semester. The presentation will be assessed for a total of 10% of the final grade.

Attendance (100 points): Attendance and tardiness will be marked at the start of each class session to reinforce the importance of in-class engagement. The total value of full attendance is 10% of the final grade.
