COURSE DESCRIPTION

This course introduces students to key research methodologies in sport and health science, including study design, data collection, and analysis. Additionally, students will learn the foundational skills required to critically evaluate research quality and apply research outcomes to improve athletic performance and health.

By the end of this course, you will be able to:

1. Demonstrate knowledge of research design and methodology by explaining study types, measurement strategies, and ethical considerations in health and wellness research.
2. Identify gaps in the literature and formulate original research questions that are clear, focused, and supported by current evidence.
3. Critically appraise the structure, rigor, and overall quality of research evidence and determine the efficacy of a clinical intervention.
4. Develop and present a research proposal that includes an appropriate study design, data analysis plan, and professional oral and visual communication of findings.

PLNU Course Modality Definitions

- **Online Courses:** These are courses with class meetings where all instruction and interaction is fully online.
 - **Synchronous Courses:** At least one class meeting takes place at a designated time.

- **Hybrid Courses:** These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
