Course Description

Arranging II focuses on applying the fundamentals of music arrangement to the platform of the Digital Audio Workstation. Arranging starts with pinpointing the emotional aim of the music then seeking to apply the principals of song form, structure, dynamics, tension & release, contrast, simplicity, repetition, groove, lyric, hook, and sonic texture to achieve the desired emotional response. These elements of arranging will also be applied to the four specific areas of modern music production: the song, the parts, the production, and the mix.

Program and Course Learning Outcomes

By the end of the semester, you will demonstrate:

- An ability to apply the principles of modern arrangement to your own productions within a DAW.
- The ability to arrange original material utilizing the skills utilized by professionals in the field today to elicit a specific emotion from the listener.
- A development in your creative capacities to compose and arrange a song on multiple levels: form, parts, production, and mix.

Required Texts and Recommended Study Resources

A professional multitrack DAW software (e.g. Logic Pro X, Pro Tools, Ableton Live), MIDI controller, microphone, interface, and headphones will be required to complete assignments.
