## Course Description

**MUA 1068, 2068, 3068, 4068, Private Saxophone (1-2 Units)** - Private, applied instruction in a performing area is a vital part of the development of Music majors, as well as an appropriate elective for many non-majors. Each level of study has defined materials and technical masteries to be achieved. (See Music Student Handbook in the Department of Music office). Students are assigned to a level according to their proficiency and mastery of materials listed for a given level.

Private lesson studies will consist of a variety of prescribed technical studies, etudes, and repertoire.

## Course Learning Outcomes

You will be able to perform a piece or pieces by the end of the semester, demonstrating both progress on your instrument and mastery of the techniques and artistry required to perform at a high level.

## Course Credit Hour Information

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1-2 unit class delivered over 14 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 37.5 total hours meeting the course learning outcomes. The time estimations are provided in the Canvas modules.

## Assessment and Grading

Grades will be based largely on the criteria below:

A = Superior preparation and effort. Demonstrated a fierce work ethic, focused drive, initiative, and actively seeks additional materials and outside inspiration. Brings independence and professionalism to the music and lesson.

B = Good. Demonstrated good preparation and shows a consistent and effective practice routine. Shows noticeable progress both musically and technically.

C = Average. Prepared but only the minimum. Demonstrates some inconsistencies in practice routine but shows enough improvement to move through assignments. Acceptable.

D = Poor. This grade is given when the student is clearly unprepared and is showing minimal effort to improve or establish healthy musical habits.

F = Received when a student has not prepared at all and has made no effort.

Note: Attendance in both lessons and juries/forums (as applicable) will also factor into the final grade.

## Trigger Warning

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In MUA x068, we will cover a variety of topics, some of which you may find triggering. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your

intellectual engagement in the area of Music, and I will support you throughout your learning in this course.
