This is a lecture and lab-based course focusing on learning the role of OT in acute care and safety in patient management.

Course Description

This lecture and lab course will prepare students to gain patient care skills needed to provide safe and effective treatment across the lifespan. Students will demonstrate competency in the assessment of vital signs, functional mobility, management of acute care equipment, adherence to HIPAA and infection control standards, and the ability to explain the role of occupational therapy to others.

4. Evaluate and discuss mechanisms for referring clients to specialists both internal and external to the profession, including community agencies.(B.3.17).
5. Demonstrate sound judgment regarding safety of self and others and adhere to safety regulations throughout the occupational therapy process as appropriate to the setting and scope of practice. This must include the ability to assess and monitor vital signs (e.g., blood pressure, heart rate, respiratory status, and temperature) to ensure that the client is stable for intervention.) B.2.8.

Grade Intervention Procedures

Scoring below a letter grade of a C (73%) in any didactic course is not considered to be a passing grade.
