COURSE DESCRIPTION

Course for students interested in pursuing a career in the health professions. This course will introduce students to the various health professions and inform them of the required preparations for these careers. This course will provide time for reflection to determine if the health professions are the right career or vocational path and which career path(s) they may want to pursue.

COURSE LEARNING OUTCOMES

Upon completion of this course, students will be able to:

1. identify and classify the biblical, historical, and philosophical nature of various health professions.
2. illustrate what it means to be a health professional.
3. describe the application and admissions processes.
4. explain and evaluate their reasons for considering their potential vocation or career path.

ASSESSMENT AND GRADING

This course is graded on a Credit/No Credit basis. Students are expected to fully participate in class activities, reading, discussions, and writing assignments in order to pass the class. Note there are three ways to fail: lack of class attendance/participation, lack of discussions, or lack of writing assignments.

PLNU ATTENDANCE AND PARTICIPATION POLICY



Regular and punctual attendance at all synchronous class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions (virtual or face-to-face), the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation.
