Course Description

A survey of psychology as an empirical/behavioral science. Topics include biological correlates of behavior, learning, cognition, emotion, motivation, personality, assessment, development, psychopathology, psychotherapy, and social psychology. Students should take PSY 1003 if they do not meet the criteria for PSY 1001. Letter grade. Prerequisite(s): PSY 1001 (may be taken concurrently)

Program and Course Learning Outcomes

By the end of this course, **students will be able to:**

1. **Explain** psychology as a scientific discipline by identifying how psychological theories are developed, tested, and revised through empirical evidence.
2. **Apply** core concepts from major areas of psychology (biological, cognitive, developmental, social, and clinical) to real-world experiences and current issues.
3. **Evaluate** claims about behavior and mental processes using critical thinking, research methods, and an understanding of common biases and misconceptions.
4. **Design and conduct** a basic psychological investigation by formulating a question, generating a hypothesis, collecting or analyzing data, and **communicating** results in a scientific format.
5. **Demonstrate** effective communication of psychological ideas through written reflections and oral/poster presentations.
6. **Collaborate** in classroom activities that require respectful discussion, active participation, and the application of psychological principles to group tasks.

By the end of this course, **students will also be able to:**

7. **Develop** an understanding of self that fosters personal well-being. (GELO 2a). Note: GELO 2a will be assessed through an assignment called "Psychology and You," described in detail on Canvas.
