Course Description

This online course focuses on the historical and cultural development of art styles from the Renaissance period to the present. The historical progression of art will be explored in conjunction with philosophical and aesthetic concepts. Art history is often presented segmented, where each genre acts as a stand-alone contribution to the much more elaborate story of art. This course focuses on history and formulates a narrative that is more cohesive and immersive. Together we will follow the story of Europe and America through the descriptive lens of art. It is a tale filled with tragedy, celebration, color, and drama. A story that revolves around artists, kings, queens, and rebellion. Through the engagement of weekly assignments, lectures, and readings you will be expected to challenge yourself and your colleagues with rich and insightful discussions. You are expected to devote 15-25 hours of online and independent study each week to be successful in this course.

Course Modality Definitions
