COURSE DESCRIPTION

Students work in teams to produce live radio programming and podcasts for Point Radio. May be repeated up to a total of three (3) units.

PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a) Synchronous Courses: At least one class meeting takes place at a designated time.
 - b) Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

ASSIGNMENTS AT-A-GLANCE

See Canvas for deadlines and assignment details.

Canvas Assignments (200 points): Students will complete a variety of assignments outside of class using Canvas. These assignments including music lists, discussions, and quizzes and will be assessed for a total of 20% of the final grade.

Live Radio Show (300 points): Students will work in groups to produce live radio programming for Point Radio. These six shows will be assessed for a total of 30% of the final grade.

Special Segments (100 points): Students will produce three special segments for their radio shows including a newscast, guest interview, and a field narrative. These three projects will be assessed for a total of 10% of the final grade.

Commercial (100 points): Students will work in groups to write, record, and edit radio commercials promoting Point Radio. This assignment will be assessed for a total of 10% of the final grade.

Goals (100): Students will write and self-assess individual goals through written reflections. These reflections will be assessed for a total of 10% of the final grade.

Final Presentation (100 points): A final presentation will be given to present your demo reel based on work produced during the semester. The presentation will be assessed for a total of 10% of the final grade.

Attendance (100 points): Attendance and tardiness will be marked at the start of each class session to reinforce the importance of in-class engagement. The total value of full attendance is 10% of the final grade.
