Outcome Measure:

CHD4020 Socialization of Self paper: Students will complete a personal case study on the effects of socialization; discuss the social and behavioral outcomes of socialization in terms of their own development; explain personal attitudes and values and discuss their own sense of self-efficacy and self-esteem; describe the influences on their moral development; explain how their own gender role developed thus far; include the socialization agents and how each has helped to shape who they have become physically, cognitively and socially.

Conclusions Drawn from Data:

In fall 2025, the 85% criterion was met for mastery or proficiency, with 100% in all categories. Connection to experience was 95%, and connection to discipline was 100%. Transfer: Adapts & Applies was 97%, Integrated Communication was 96%, and Reflection & Self-Assessment was 100%. Overall scores increased slightly from fall 2024, and the percentage in mastery increased significantly in Integrated Communication and Reflection & Self-Assessment. Mastery decreased in Transfer: Adapts & Applies.

It is important to note that a focus has been on Integrated Communication; the signature assignment is a strong tool for assessing this learning outcome. CHD 4020 is the capstone for Child and Adolescent Development majors, and it is the perfect course to assess this outcome.

Changes to be Made Based on Data:

The changes made in 2024 are in how assignments are scaffolded and explained. Continuing to providing reflection time in class and including guiding students through prompts will be continued. The focus on helping students transfer and apply their understanding of theories into making sense of practical situations will continue to be a focus in this course as they learn to develop their depth of understanding.

CHD4020: Article Critique. Students read, then summarize, a current article about any topic in child development of interest a non-professional magazine, newspaper or online. Students then write their own opinion based on a thorough, critical analysis of the article; addressing the advice given, the opinions and any research given as support for the original article. In their critical evaluation, students must use and cite at least one other article from a professional, peer-edited journal that supports or discredits the article with documented research.

Conclusions Drawn from Data:

The criterion of 85% was met in all categories, including mastery and proficiency at 100%. This was significant when you compare scores from 2023: and the fact that they continued to be high in 2024 & 2025. Increase of mastery Use of Information 29% to 58% effective in accomplishing a specific purpose was significant. The assignment was carefully scaffolded over the years.

Changes to be Made Based on Data:

This signature assignment is an effective tool for measuring this learning outcome. This signature assignment will continue to be carefully scaffolded with a focus on depth of conclusion. Both assessors commented on the fact that reading the papers was encouraging because the overall competencies have improved.

Students will complete an annotated bibliography of all research materials found.

Conclusions Drawn from Data:

The criteria of 85% scored 3 or higher in each category were met in all categories, with the exception of identifying strategies at 84%. Define problem 100%, evaluate information 100%, use information effectively 96%, propose solutions 92%, and access and use information 92%. A goal from last year Spring 2024, was to increase Evaluate information and its source critically. Last year it was at 80% this year, it increased to 84%. While improvement was shown, it still did not meet the 85% criteria. Another goal from last year was to reach mastery level, and that still needs to be accomplished, with the exception of access and use information, which went from 22% to 72%.

Changes to be Made Based on Data:

Lessons learned from previous assessments indicate that classroom scaffolding and scaffolding by the Library Faculty can be extremely helpful in giving students effective strategies for evaluating and collecting peer-reviewed resources. This scaffolding includes understanding how to properly cite, search, and use APA format. It is important that this scaffolding is very intentional and developed throughout

the program. The recommendation will be to continue to scaffold each aspect of this signature assignment. The recommendation is to offer CHD 1020 in fall, not spring. This change will be made 2027-2028 if approved by the dean. That is the course where scholarly writing is introduced, and it's developed in CHD 3055 in spring. We have had transfer students take them in the same semester. It is important to separate these courses so that they can be introduced and developed.

Conclusions drawn from the data:

CHD 3013, Adolescent Development in the Family Context, is offered every other year, and the signature assignment will remain for PLO 4. CHD 3003- Infant and Toddler Development, will be assessed in the other years. These two courses are both taught every other fall. CHD 3003 will be offered fall of 2026. The criteria of 85% were met across the board in all categories with the exception of: Determine Extent of Information: 83% & Access Needed Information: 80%

Evaluate Information/Sources: 98%

Use Information Effectively: 90%

Access and Use Information: 86%

This signature assignment is challenging for our students because they need to synthesize the information (a supplemental book, the course textbook, and their own knowledge) and critique if the supplemental book is good child development practice or not.

Changes to be Made Based on Data:

*Historical context: In previous years, an area of concern was Evaluate Information/Sources (79% in 2024) and Access and Use Information (64% in 2023 and 80% in 2024). Because of this, we partnered with library faculty to create an information literacy course integration in Fall 2025 that provided structured practice at accessing and using different types of sources and critically evaluating information and sources. The data suggests that this integration resulted in improvement in both of these areas, especially in evaluating information/sources.

Evaluate Information/Sources: improvement from 79% (2024) to 98% (2025)

Access and Use Information: improvement from 80% (2024) to 86% (2025)

CHD 3003 (Infant and Toddler Development) will be taught in Fall 2026. Due to the improvement of these scores, we will implement a similar information literacy course integration in CHD 3003. In addition, the data suggests that students need more support with accessing

needed information. This area dropped from 88% in 2024 to 80% in 2025. Because of this we will incorporate more structured practice at using the textbook to either support or refute claims surrounding child development, and also make the expectation of including references to the textbook more clear in the assignment description and rubric.

Conclusions Drawn from Data:

85% criteria were met in all three categories Fall 2025 & Spring 2026: Application of Ethics and Values 100%, Analysis of Vocation 100%, and Synthesis of Faith 100%. This has been carefully scaffolded, and successful practices have been put into place over the years.

Changes to be Made Based on Data:

To continue to scaffold development with their professional statements. This includes professional philosophy and personal code of ethics. Starting Fall 2020, from recommendations from assessment, two mandatory consultations with faculty were added to the course, first in the beginning draft and then in the final draft of the Code of Ethics and Professional Philosophy. This practice of two consultations on professional statements is now part of the fabric of this course. Fall 2026 and spring 2027 will continue to articulate how faith can be intertwined into their professional statements and philosophies. However, the department wants to focus on the authentic synthesis of faith of who they are and not write what they think we want them to write.
