COURSE DESCRIPTION

This is the third of five sequential clinical education courses. The aim of this course is to equip students who are pursuing a career in Athletic Training with the basic knowledge and skills required to care for the physical and mental needs of the physically active. In the process, students will develop an emerging mastery of the Educational Standards established by the Commission on Accreditation of Athletic Training Education (CAATE). In addition, there will be instruction and supervision in an off-campus clinical setting by a Clinical Preceptor. This course places an emphasis on professional development.

PROGRAM LEARNING OUTCOMES

The Point Loma Nazarene University MS-AT graduate will be able to:

1. Demonstrate the knowledge and skills required to become a certified athletic trainer.
2. Critically evaluate and integrate the best available evidence for clinical decision-making.
3. Deliver new evidence that is intended to change clinical practice in various healthcare communities through scholarly research presentations and symposiums.
4. Describe the importance of collaborating with multiple healthcare professionals and diverse patient populations to improve patient care.
5. Demonstrate preparedness for their vocation and calling.

COURSE LEARNING OUTCOMES

In this course, you will learn how to:

1. Demonstrate effective communication skills when interacting with patients, families, and members of the healthcare team to ensure patient-centered care. (Standard 59 and 61)
2. Apply ethical principles and professional standards to ensure compliance with laws, regulations, and the BOC Standards of Professional Practice in athletic training. (Standard 65 and 66)
3. Assess professional strengths and areas for growth to create a personalized plan for ongoing professional development while demonstrating leadership and advocacy for the athletic training profession. (Standard 67 and 68)

You will engage in an [Interprofessional Education for Healthcare Professions](#) Canvas learning experience where you will learn how to:

4. Work with team members to maintain a climate of shared values, ethical conduct, and mutual respect (IPEC Core Competency Values/Ethics).
5. Use the knowledge of one's own role and those of other professionals to appropriately assess and address the health care needs of the patients and to promote and advance the health of populations (IPEC Core Competency Roles and Responsibilities).
6. Communicate in a responsive, responsible, respectful, and compassionate manner with team members (IPEC Core Competency Interprofessional Communication).
7. Apply relationship building values and principles of the science of teamwork to adapt one's own role in a variety of team settings (IPEC Core Competency Teams and Teamwork).

In this course, the following CAATE Standards will be met:

 6. regulations pertaining to over-the-counter and prescription medications
5. Standard 67 - Evaluate professional competence and create professional development plans according to personal and professional goals and requirements.
6. Standard 68 - Advocate for the profession.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 3-unit clinical course delivered over 16 weeks. Specific details about how the class meets the credit hour requirement can be provided upon request.

CLINICAL COURSE CREDIT HOUR POLICY

Each clinical course within the athletic training program is worth 3 units of credit. See below for course credit hour and clinical hour expectations:

- 1 course credit hour = 75 - 149 hours of clinical experience
- 2 course credit hours = 150 - 224 hours of clinical experience
- 3 course credit hours = 225 - 435 hours of clinical experience

In addition to completing clinical hours, students are required to attend the regularly scheduled instruction sessions for the clinical course.

CLINICAL ROTATION REQUIREMENTS

To fulfill the clinical rotation requirements of this course, students must participate in a hands-on clinically immersive learning experience (30-40 hours per week) lasting at least 4-weeks in one of the following clinical settings: high schools, colleges, professional sports organizations, physician practices, or occupational medicine facilities. Students will be required to complete additional clinical hours at one or more of the settings listed to above to ensure they meet the clinical hour requirements for the course. All clinical rotations will be supervised by a credentialed healthcare professional. Rotation start dates are

up to the discretion of the clinical site and may begin anytime between May 11, 2026 August 10, 2026. Students will have until September 13, 2026 to complete their clinical rotation and hour requirements.

Elements Required For Passing ATR6092

1. Meet the minimum clinical hour requirements (see clinical hour policy).
2. Complete all Interprofessional Education (IPE) requirements assigned to the clinical course.
3. Adhere and uphold all clinical policies and procedures throughout their clinical rotations.
4. Score “proficient” in all professionalism categories of the final Athletic Training Student Evaluation.
5. Score “advanced beginner” or higher in the summative assessment category of the final Athletic Training Student Evaluation.
6. Achieve a grade of 73% or higher in the assigned clinical course.

Note: Failure to meet the requirements above will result in clinical remediation. Please refer to [Clinical Remediation Policy](#) for more information.

Students must complete the required program hours in the major (program) from Point Loma Nazarene University with a minimum grade of “C” in each course and an overall 3.00 grade point average.

Interprofessional Education for Healthcare Professionals

Students are required to participate in and complete the Interprofessional Education for Healthcare Professionals course in Canvas. To receive full credit, students must complete all four learning modules and all associated assignments with a grade of “C” or higher. In addition, students are required to attend the in-person IPE event on June 5. Failure to attend the event will result in an automatic failing grade for the course. Exceptions will be made only for documented emergencies or absences that have been pre-approved. Students must notify the course instructor(s) in advance if they anticipate any conflicts that may affect their attendance.

All assignments must be submitted by the specified due dates in Canvas. Incompletes will be granted only under exceptionally unusual circumstances.

PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

Students who anticipate being absent for an entire week of a course should contact the instructor in advance for approval and make arrangements to complete the required coursework and/or alternative

assignments assigned at the discretion of the instructor. Acceptance of late work is at the discretion of the instructor and does not waive attendance requirements.

PLNU Course Modality Definitions

1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
1. Synchronous Courses: At least one class meeting takes place at a designated time.
2. Asynchronous Courses: All class meetings are asynchronous.
2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

Synchronous Attendance/Participation Definition

For synchronous courses that have specific scheduled meeting times (including in-person, hybrid, and synchronous online courses), absences are counted from the first official meeting of the class regardless of the date of the student's enrollment. For courses with specific attendance requirements, those requirements are outlined in the course syllabus.

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.
